**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE
BID AND RECOMMENDING THE AWARD OF CONTRACT**

APPROVED BUDGET FOR THE CONTRACT (ABC): ₱ 1,727,750.85

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Completion of TLE Building with an Approved Budget for the Contract (ABC) of ₱ 1,727,750.85 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on January 3, 2023;

WHEREAS, in response to the Invitation to Bid, two (2) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) January 11, 2023;

WHEREAS, in the public bidding held at the Business Center Audio Visual Room (TSU-BC AVR) on January 24, 2023, at 10:00 A.M.:

- (a) two bidders, namely, High Vision Builders Corp. and Slampjam Construction tendered bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found the first envelopes of the two bidders to contain all the required documents and were rated "passed",
- (c) the BAC, with the assistance of the TWGs, evaluated and ranked the bids of the two bidders,
- (d) the BAC resolved to declare Innovative High Vision Builders Corp. as the bidder with the Lowest Calculated Bid (LCB) with the bid price of ₱ 1,554,964.16, and
- (e) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB;

WHEREAS, in the Post-Qualification Evaluation Conference held at the Business Center Audio Visual Room (TSU-BC AVR) on February 21, 2023:

- (a) the TWGs reported that LCB was found to be non-responsive on the ground that the bidder failed to substantiate the SLCC claimed in its bid,

- (b) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the LCB as non-responsive and upon motion duly seconded, declared the LCB as post-disqualified,
- (c) the BAC directed the TWGs to proceed with the post-qualification evaluation of the bid of Slampjam Construction, the second Lowest Calculated Bid for the aforementioned project, and
- (d) the BAC directed the Secretariat to issue the Notice of Disqualification to High Vision Builders Corp.

WHEREAS, in the Post-Qualification Evaluation Conference held at the Business Center Audio Visual Room (TSU-BC AVR) on March 7, 2023:

- (a) the TWG for the Financial and Legal Aspects reported that the bid of Slampjam Construction was responsive to the legal and financial requirements for the project,
- (b) the TWG for Technical Aspect reported that the bid of Slampjam Construction was responsive to the technical requirements for the project, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the bid of Slampjam Construction as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- (a) to declare the bid of Slampjam Construction as the bidder with the Lowest Calculated and Responsive Bid with the bid price of ₱ 1,555,069.37 and
- (b) to recommend to the President the Award of Contract for the project Completion of TLE Building to Slampjam Construction.
